## High Point Medical Society Endowment Fund

Every member of the medical community is dedicated to preserving the health of patients to the best of their ability. Yet for every patient we help, we know there are still other community health care needs that remain beyond our individual reach. These too deserve our attention. In an effort to extend our concern into the wider community, the High Point Medical Society has established a permanent Endowment Fund which supports worthy programs working to improve community health.

The Endowment Fund, created in 2006, will preserve its principle in order to generate income for perpetual allocation. Thus, donors are assured that their gifts will retain their value well into the future, providing a lasting "gift of health" to those in need.



### Grants

Grants from the Endowment Fund are reserved for community agencies and programs providing health related services. Each application is carefully reviewed by an advisory committee consisting of members of the Medical Society. They in turn act under the advisement of their respective membership as well as the distribution committee of the High Point Community Foundation.

## Management

The Endowment Fund is professionally administered by the High Point Community Foundation, a funded and directed endowment that provides services to donors, not-for-profit agencies, and the general community by "serving the donor's interests and the community's needs ." The High Point Community Foundation was founded in 1990 as a public charity established to increase private philanthropic resources in the Greater High Point area.

By partnering with the High Point Community Foundation, the High Point Medical Society gains efficient administration of its fund, and broad diversification of its investment assets.

## Opportunities for Giving

Contributions of any size are welcome. The Fund accepts individual or group gifts from the medical community.

A gift to the Endowment Fund can be an especially thoughtful way to express appreciation to your personal physician or friends in the medical profession, or to honor the memory of a loved one.
